Minutes:

- The boards of AACC and IFCC, and the Council of ICHCLR have agreed to transfer the secretariat to IFCC. The Task Force appointed by IFCC has prepared a draft memorandum of understanding (MOU) to transfer the secretariat effective 1 January 2018. IFCC is expected to send the MOU to AACC for signature.
- Gary will initiate communication in November with current Council, Organizational and SPG members inviting them to continue participation for 2018 at the new annual contribution rates.
- 3. The web site will be revised to reflect new member categories and operating procedures toward the end of the year to coincide with recruitment of new members after the secretariat process is finalized with IFCC.
- 4. Each HOG member agreed to contact colleagues in their countries to identify organizations with active harmonization activities that we can add to the web site.

- 5. The CAP suggested to add links to PT/EQA programs that use commutable samples. The HOG agreed this will be a useful service. We can consider changing the measurand table header from "JCTLM" to "Resources" (or other term to be determined) and include both JCTLM and commutable PT links. Some PT programs include a mix of commutable and non-commutable samples so we will need to determine how best to designate. HOG members in different countries can provide information for PT programs in their countries that offer commutable sample programs. A system for annual update should be developed. We will revisit how to set up this new service.
- 6. Measurands were reviewed as indicated in the table that follows. The goal is to complete these measurand assessments for the next call.
- 7. Next conference call meetings are November 22, and December 13.
