Council activity:

HOG activity:

 ICHCLR and EQALM signed a memorandum of understanding in 2019 to develop a program to aggregate EQA data from different countries as feedback on harmonization status. A report of the pilot study was published in Clin Chem Lab Med 2020 Aug 6;/j/cclm.ahead-of-print/cclm-2020-0736/cclm-2020-0736.xml. doi: 10.1515/cclm-2020-0736. ICHCLR has agreed to take the lead in further developing the initiative. Minutes from an organizational call including Gitte Henriksen, who will chair the project, and Wim Coucke representing EQALM, Greg Miller and Gary Myers representing ICHCLR were circulated before this meeting. A steering committee will be formed to develop the plans for expansion of the project to include additional EQA providers and measurands.

- 2. Gary reviewed information from Chris Sempos explaining the roles of IFCC, CDC and the NIH Vitamin D Standardization Program in standardization of results for vitamin D. Gary and Susan will collaborate to finish the discussion for the measurand table. Greg and Ian will inform the chairs of each program of the overlap and if better coordination of resources can be accomplished.
