Minutes:

- 1. Four new HOG members were welcomed to the group: Dr. Anja Kessler, Dr. Melissa Snyder, Dr. Yeo-Min Yun and Dr. Andy Hoofnagle. These new members bring expertise to expand that of the other members.
- 2. Gary reported that he has reviewed two pages of measurands for any with JCTLM resources. He will send the list to Greg to update the web pages.
- 3. Gary has communicated with current Council, Organizational and SPG members to invite them to continue participation for 2018 at the new member classifications and annual contribution rates. CAP and KSLM have initiated the renewal process for Council membership and Roche Diagnostics for Stakeholder membership. Qualab Biotech Co. from Shanghai, China has applied as a new Stakeholder member.

- 4. This point is retained from a previous call to ensure follow up. The CAP suggested to add links to PT/EQA programs that use commutable samples. The HOG agreed this will be a useful service. We can consider changing the measurand table header from "JCTLM" to "Resources" (or other term to be determined) and include both JCTLM and commutable PT links. Some PT programs include a mix of commutable and non-commutable samples so we will need to determine how best to designate. HOG members in different countries can provide information for PT programs in their countries that offer commutable sample programs. A system for annual update should be developed. We will revisit how to set up this new service.
- 5. Measurands were reviewed as indicated in the table that follows. We have almost completed review of the spreadsheet based on most frequently ordered lab tests. The next step will be to review lab tests that need to be harmonized based on inclusion in clinical practice guidelines.
- 6. Greg will edit the spreadsheet to remove measurands that are completed.
- 7. Next conference call meetings are March 29 and April 25 at 8-9 AM USA Eastern Daylight time. Note the call time has been moved one hour later in the day to accommodate time zone differences among members.
